Old Business –

Chase, and seconded by B. Beattie, approved by all. 1 extra soccer shirt was ordered – will need bill submitted for payment.

#2 Fall Fundraisers – Haunted House Committee has had two meetings with the next one scheduled for October 19, 2010 at 6:30 PM. Haunted House will be held on October 30, 2010 from 6:00 – 9:00 PM. The first hour 6:00 – 7:00 will be for the light hearted – less scary. From 7:00 – 9:00 will be no holds barred – real scary. Wish list for items/decorations needed was sent last Thursday via email only. Another list will be sent in this Thursday's notes. We will need about 30 actors/volunteers for this event. Will need to find out how many pumpkins we are getting.
